7. Budget/Finance Committee (Chair McNamara). McNamara introduced the 2026 Budget, which was provided to the Board for review. CMFO Calise provided additional details. It was explained that claim projections have been developed with input from the NJIIF's Actuary. Further, J. Gallo commented that the budget line for excess insurance is based on preliminary estimates and that he should have the final quotes by late November.

9. Director of Marketing Report (Barlas). Barlas reported that underwriting for numerous prospective members is underway and that proposals will begin being submitted later this month.

10. Loss Control Consultant Report (PMA/T. Weir). Weir reported that PMA provided onsite risk control services to 14 members over the last month, in addition to online/phone contacts with Brokers and Risk Managers, including but not limited to participation in safety meetings, loss cause focus issues, compliance-based education, assistance with PEOSH related issues, and other areas needing risk control assistance. Additionally, Weir reported that Verona DPW took first place in the October 9, 2025 Snow Plow Rodeo. Finally, Weir reminded the members of upcoming PMA online training, including a December 11, 2025 session "*When Vehicle Crashes Occur: Follow this Simple, Effective Approach*".

11. TPA Report (J. Signs/PMA TPA). J. Signs provided an update on aggregate WC claims received through 11/1/25. It was reported that to-date, several Members have no reported claims for 2025, and that for those claims filed so far in 2025, many Members have 100% on-time reporting. Further, Signs reported that no new COVID claims have been received since 2023, and reported that out of 110 related claim petitions, only 23 remain open.
