 - g. <u>Safety/Risk Management Committee</u> (Lazorisak). Commissioner Lazorisak reported that Warren County will be purchasing cyber security software offered by Rubrik Security and suggested that other NJIIF Members may want to consider using this system. Additionally, Lazorisak raised the issue of an increase in social media OPRA requests and how municipalities are handling responses. Commissioner Lazorisak also brought up the State's "Daniel's Law" and is seeking input on how other NJIIF members are responding to the administrative mandates of that law.
 - h. Member & Development Committee (Kazmark) Commissioner Kazmark provided the background on Resolution NJIIF-P-2023-014, for the appointment of a website designer and web host that would be retained in order to update the NJIIF's website. Kazmark and Marketing Director/Co-Administrator Barlas reported that MAD Global Strategy Group's proposal includes services to redesign the NJIIF logo as well as training for use of the website. - 7. <u>Risk Manager's Report</u> (Polaris Galaxy). J. Gallo reported that most of the NJIIF Member assessment April invoices have been sent. Gallo also reported that he has received a final quote from L-Biz Appraisals and the property appraisal process is moving forward.
- 8. <u>Director of Marketing Report</u> (Barlas). Al Barlas reported that introductory meetings with "Inventive" regarding its RMIS software have taken place, and that he is hoping to conference with Origami Risk, with respect to their claims management software. The goal is to provide member access to numerous NJIIF insurance products and services through the NJIIF website.
- 9. Loss Control Consultant Report (PMA) Tim Weir reported that based upon the success of its Risk Control Forum conducted in February for law enforcement, PMA is working on a similar seminar for Member Fire Departments. Weir further advised that his office provided direct risk control services for six members over the past month, including participation in safety meetings, compliance-based training and assistance with PEOSH related issues. Finally, Weir reminded everyone of PMA's Safety Seen Newsletter that is sent every month as well as the resources available through PMA's Websource sessions.
- 10. <u>TPA Report</u> (PMA) Jennifer Signs provided an update on aggregate WC claims received through 3/1/23, including the number of reported COVID cases. She also reported that the total claims reported to date in 2023 are substantially lower than for the same period in 2022 and is below the 5-year average. She reported that claims generally continue to be timely reported. Signs further reported that the NJIIF has a total of 407 reported COVID cases with 96 related claim petitions filed to date.
